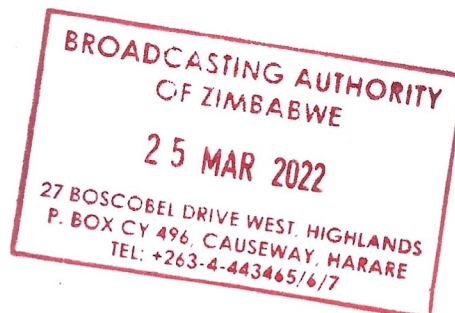
Also note that on the same page 3, item number 8, the statement should state that:

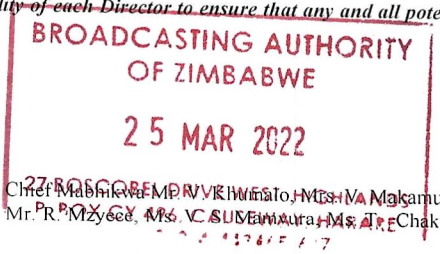
NOTES

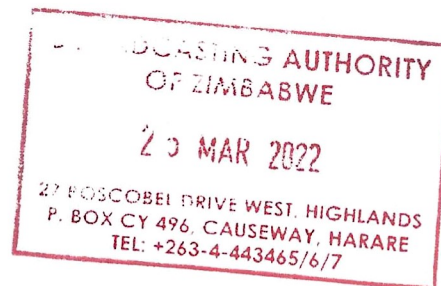

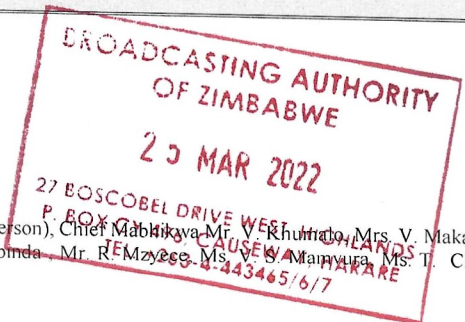
